2. Minutes of the last meeting of the Committee

Dr R Longton provided a verbal update to members regarding the NDP Steering Committee and its progression to date. The area designation form has been submitted to West Berks Council for their consideration.

Members have been asked to sign, acknowledging they had read and understood the terms accordingly. Committee members are also to be reminded of their obligation to complete Register of Members Interest forms, ensuring any interests are disclosed accordingly.

iii) To consider any changes in Planning legislation and its impact upon Burghfield

Liaison is being held with West Berks Council in relation to the advantages and merit in reviewing and updating the Village Design Statement. A report will be prepared and presented at the next committee meeting for consideration.

A publication has been released from the Government in relation to "Fixing the Broken Housing Market". Members can request copies of the document from the parish clerk.

iv) <u>To give consideration to the Royal Berkshire Fire & Rescue Service consultation</u> document and determine suitable comments for return

Members present gave consideration to the Royal Berkshire Fire & Rescue Service Redesign Consultation. The consultation focuses on the changes needed to make their Prevention, Protection and Response work in order to save £2.4 million by April 2020. Comments are to be submitted in relation to the retention of Mortimer Fire station being a very positive outcome locally.

#### 6. Transport

 To consider any Highway or Road Safety improvements for implementation within the parish

The lines at the junction of School Lane and Recreation Road, on the corner of the Common Recreation Ground, are to be added to the list of areas within the parish requiring for re-painting by West Berks Council.

West Berks Council have been asked to review the potential for a crossing point between the Willink Secondary School and at the corner of Recreation Road following the request being presented by students at the youth council meeting.

BT is to be requested to return to Birch Road to complete their street works to a satisfactory standard. West Berks Council is to be advised of the disruption caused and the standard of work employed by BT to the footway.

ii) To determine the locations for the next deployment of the SID within the parish

Members gave consideration to the preferred locations for the deployment of the SID during May and June, determining the following locations:

- Hawksworth Road
- Clayhill Road
- Reading Road, by the Methodist Church and by The Forge

### 7. <u>Green issues</u>

i) To give consideration to any green issues within the parish requiring action

The solar panels on the village hall continue to perform well, providing a valuable source of energy and considerable reduction in the council's carbon footprint.

An application has been submitted for a grant to undertake the replacement of all lighting within the village hall to LED's

To receive an update in relation to BPC owned street lights and the LED replacement programme

The next phase of the installation of street lights has been completed by SSE. The next phase is to be considered by members for installation in the new financial year. Boldrewood & Jordans Lane are to be requested within the next phase, completing all outstanding lights within the parish.

### 8. To receive an update in relation to Section 106 projects within the parish

i) To confirm the location for the proposed hand rails on the footpath between Pine Ridge Road and Clayhill Road

Confirmation was provided that the handrail requested will be installed on footpath between Pine Ridge Road and Clayhill Road prior to the financial year end.

9. To determine future agenda items for discussion – No items were identified by members present for future discussion.
