Open Meeting

The low attendance and the absence of any questions resulted in a brief open meeting.

176. To receive any written requests for Disclosable Pecuniary Interest dispensations from Members

There were no items upon the agenda that necessitated a member to present a written request for dispensations for a Disclosable Pecuniary Interest.

177. Minutes of the last Parish Council meeting

Resolved that the minutes of the meeting of the Parish Council held on 12 February 2015 be approved as a true and correct record and signed by the presiding Chairman.

178. Matters Arising on the Minutes

Works are nearing completion for the installation of the Multi Use Games Area on the Common Recreation ground. The spring edition of the newsletter was circulated this week to all residents.

179. Chairman's Report

The presiding Chairman gave a brief report on activities and events attended since the last meeting, highlighting the topics raised at the Annual Parish Conference held at the West Berks Council offices.

The Chairman advised members that Network Rail are due to hold a workshop on 17th March regarding the potential

180. <u>District Council Report</u>

Dr R Longton presented a brief verbal report to members highlighting specific concerns relating to Burghfield. A copy of the report is attached to the minutes for reference.

184. To receive an update regarding the installation of PV Panels on the village hall and consider any action required for the progression of the project

In progressing one of the key points identified within the parish plan refresh document, the council has been pursuing alternative Energy provision. The main aim is to reduce the carbon footprint of the parish by encouraging a reduction in consumption, the promotion of renewable energy and an increase in energy saving measures within Parish where possible.

Members were advised the village hall had recently undergone an EPC (Energy Performance Certificate) check to determine its rating prior to the installation of the PV panels. To ensure the higher level Feed in tariff being applied a minimum efficiency rating of a "D" is required. The age and efficiency of the currently boiler has resulted in an unsatisfactory rating, potentially impacting the feed in tariff rate to be applied. Investigations have been held into alternative boilers, with a preference for air source heat pumps to enable full utilisation of the existing ducting. Proposed by Mr I Macfarlane, seconded by Mr C Greaves and **resolved** unanimously the following action is taken:

To progress with the installation of the PV panels week commencing 13th April but leave the system closed off until the replacement boiler has been installed.

- ii) To obtain quotations for air source heat pumps for consideration and approval by the Governance & Finance committee as soon as possible.
- iii) To apply for funding from WBC to assist with the costs in replacing the boiler
- iv) Upon installation of the air source heat pump, link up the supply to the PV panels and apply to the FiT Bureau accordingly
- v) To ensure all of the above is completed prior to 1st September 2015.
