iii) To deal with any other planning related matters

To give consideration to the West Berkshire Local Plan Review (LPR) to 2036 Regulation 18 Consultation 9 November – 21 December 2018

Members present discussed in detail the WBC Local plan review up to 2036.

Concerns were raised by members, specifically in relation to the new Eastern Area being proposed within the plan, increasing the potential for development within the locality significantly. The inclusion of Burghfield with Tilehurst, Calcot and Purley is a further cause for concern, particularly with the proposed development of a Garden City in Grazeley in the near future. Members confirmed unanimously their objection of the creation of a new Eastern Area and the inclusion of Burghfield.

A request was presented for the NDP steering committee to work towards a draft plan as soon as possible to ensure that, as and when houses are developed, they are in a design and location favoured by the community. Dr R Longton is to seek guidance from WBC as to the level of progress required for consideration to be given. Bryan Lyttle, Head of WBC Planning, is also to be requested to attend a NDP meeting to assist in gaining clarification.

Members reiterated the need to work together to achieve a coordinated view in relation to potential sites for development within the parish and surrounding area. Consideration was given to instructing a planning consultant to assist in the formation of a detailed response to WBC and consider the future of Burghfield and further developments. Liaison is also to be held with the surrounding parishes

Proposed by Mr T Ansell, seconded by Mr D Kellaway and **resolved** unanimously that an extraordinary meeting is scheduled with representatives from Burghfield, Sulhamstead, Mortimer, Beech Hill and Wokefield and the NDP Steering Committee being invited to attend. Publicity of the meeting is to be posted accordingly to encourage parishioners to attend with a view to preparing comments for submission to WBC in relation to the consultation. A proposed date of Thursday 13th December was suggested.

WBC is also to be asked whether comments could be submitted after the 21st December due to the timings of meetings during the festive season.

Transport

i) <u>To consider any Highway or Road Safety improvements for</u> <u>implementation within the parish</u>

Concerns were expressed in relation to the roadworks on Reading Road for the installation of new gas pipework. WBC advised that works scheduled for Hollybush Lane had been delayed avoiding any further disruption within the parish.

Concerns were raised in relation to the bus stop on Recreation Road and the traffic congestion it causes when existing and entering the car park.

ii) <u>To receive an update in relation to the potential purchase of a speed</u> <u>radar unit</u>

Members present reviewed the response from Transport & Countryside (WBC). Further discussions with WBC were held in relation to the rules and criteria set out by Highways. An overview of the parish owned columns/lampposts was presented to members. Further clarification is to be sought from the speed team at WBC to determine a way forward in the purchase and erection of the unit.

7. <u>Safer Communities</u>

i) Policing & Anti-social behaviour issues

Members were alerted to burglaries having taken place at both Wellers Fruit Shop and Waring's bakery last week.

8. Parish Maintenance Issues

i) <u>To receive a report highlighting maintenance carried out during the previous month</u>

The parish handyman continues to ensure all the hedges within the parish are maintained accordingly. Clearance works have also commenced at the Common allotment site to ensure all debris is removed.

ii) Footpaths & Bridleways within the parish

A meeting has been scheduled with WBC to pursue the works previously suggested on the bridleway between School Lane and Garlands. A further request to WBC has been presented for a litter bin at either end of the bridleway. A response is awaited.

A request is to be resented to WBC in relation to the uneven compaction of the newly installed pathway running along the far end of the Hatch Recreation ground.

iii) Grit bins
