## 7.10 Grit Bins

To receive an update in relation to the Grit Bins within the parish

Members were advised a review of the parish grit bins had been undertaken, determining all were prepared for the winter period.

## 8.10 Transport

### i) To consider any Highway or Road Safety improvements within the parish school 'drop off and collection areas

Members discussed the implementation of timed slots within the parish for no parking within the vicinity of the local schools.

Resolved: To request that Enforcement visit the parish on a regular basis. Discussions are to be instigated with West Berks to determine specific dates.

### ii) To receive an update on scheduled dates for the deployment of the SID within the parish

Members determined the SID was to be requested from WBC for deployment within the parish at the following locations:

Reading Road, from Roselawn Hotel to Post Office Lane, in both directions.

Reading Road – from the Methodist Church to the Esso.

Clayhill Road – in both directions

Hermits Hill – in both directions

### iii) To receive an update regarding the speed indicator device (SID) on the Reading Road

Resolved: To present a formal complaint to West Berkshire Council in relation to the erection of a SID on Reading Road without prior consultation being held with the parish council. The location of the SID was of concern to the parish council which is to be conveyed to WBC in the correspondence.

### iv) To receive an update regarding traffic in Jordans Lane

Following discussions, members present supported, in principle, the suggestion presented by a resident for Jordans Lane to be a one-way system.

Resolved: To obtain quotations from Road Safety specialists and West Berks Council as to potential solutions for improved road Safety within the locality of the schools.

#### Policing & Anti-social behaviour issues

Members were advised the number of incidents within the parish had increased, particularly at the Common Recreation Ground.

### 10.10 **Parish Maintenance Issues**

#### i) To receive a report highlighting maintenance carried out during the previous month

The parish handyman has been undertaking maintenance required within the parish, specifically the hedges and grass cutting.

#### ii) To note any items within the parish requiring action

The entrance to the Common Rec is to be reviewed to ensure accessibility for all users. The clerk is to investigate accordingly.

#### To determine any specific actions to reduce the environmental impact within the parish

Members determined the progression and implementation of restricted parking times and drop off times outside schools would result in a reduction in the environmental impact locally.
