# Burghfield Village Hall Hirers Privacy Notice 2021

#### 1. Introduction

When you hire the Village Hall, the information which you provide (personal information such as name, address, email address, phone number) will be processed and stored so that it is possible to contact you and to respond to your correspondence, provide information, send invoices and receipts relating to your hire agreement. Your personal information will not be shared with any third party without your prior consent.

# 2. When you contact us

The information which you provide (personal information such as name, address, email address, phone number, organisation) will be processed and stored to enable us to contact you and to respond to your correspondence, provide information and/or access our facilities and services. Your personal information will be not shared or provided to any other third party.

# 3. The Councils Right to Process Information

General Data Protection Regulations Article 6 (1) (a) (b) and (e)

- i) Processing is with the consent of the data subject or
- ii) Processing is necessary for compliance with a legal obligation or
- iii) Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller.

#### 4. Information Security

Burghfield Parish Council (BPC) has a duty to ensure the security of personal data. We ensure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is achieved through appropriate technical measures and appropriate policies. Copies of these policies are available on request. BPC will only keep your data for the purpose that it was collected, and only for as long as is necessary; after which it will be deleted. You may request the deletion of your data held by BPC at any time.

# 5. Access to Information
