Sulhamstead, Reading

A verbal report was presented updating members of progress in the production of the NDP document to date. The draft document is to be presented at the May parish council meeting for presentation to parishioners at the Annual Parish Meeting scheduled for 12th May 2022.

8.0222 <u>Transport</u>

i) To receive an update on Highway issues raised at the previous meeting

Members received an update of actions to date pursued by the local school to deter dangerous parking and speeding at both drop off and collection times. Consideration is to be given by members as to whether any further actions can be encouraged to minimise the situation.

Concerns were expressed regarding the parking of workmen on Recreation Road, opposite the village hall. Members acknowledged the danger experienced at the corner of Reading Road and Recreation Road, specifically parking immediately in front of the Post Office. Concerns are to be raised with WBC highways.

ii) To receive information in relation to the West Berks Council School Street Pilot Scheme

Members received information relating to the School Streets Pilot Scheme being trialled by West Berks Council in Calcot. Interest in the scheme has been submitted. WBC have advised that upon review, scheduled for March 2022, discussions will be initiated.

Members were advised of a new PCSO having been appointed for the local area. A request was presented for evening patrols to be incorporated at the village hall, the skate park and the pavilion following some minor vandalism.

The grit bin in Lambden Way has been removed following damage. A replacement has been sourced but delivery lead times are extensive. The litter bin at the skate park has also been damaged and required removal. A replacement is on order.
