Members received a verbal update of progress to date in relation to the proposed footway between Mortimer and Burghfield. A pre-planning application has been submitted to WBC and received with support. All relevant landowners have been contacted and are supportive of the project. Suggestions for a better crossing are being considered accordingly.

7.0122 To receive an update from the NDP group and discuss future progression of the document

A verbal report was presented updating members of progress in the production of the NDP document to date. The draft document is to be presented at the April parish council meeting.

8.1121 <u>Transport</u>

i) To consider any Highway or Road Safety improvements within the parish

Members noted that the manhole cover on the Reading Road had been subject to further works from Thames Water.

The road sweepers are to be requested for the far end of Reading Road to address the mud.

ii) To receive an update on Highway issues raised at the previous meeting

The request for the white lines to be repainted on School Lane, at the junction of Recreation road, has been submitted to WBC as is awaiting assessment by Highways.

The request for the yellow lines to be repainted on Clayhill Road to deter parking specifically within the vicinity of the shops has been submitted to WBC as is awaiting assessment.

A request for the upgrade of the pedestrian walkways on Recreation Road and Reading Road have been submitted to WBC and await further assessment.

Clarification has been sought from WBC following a request being presented for a Traffic enforcement officer to deter inconsiderate parking. Members confirmed the areas to predominantly be those surrounding the school and shops.

Liaison is to be held with WBC, Grazeley, Ufton Nervet and Ashford Hill regarding the success of installing a car park within the vicinity of schools to alleviate parking.

Members had been alerted to a HGV being parked regularly on School Lane. The company is to be contacted to request the vehicle is not parked within a residential area.

Parking outside Willink & Mrs Bland's on both sides of the road is causing considerable

concern to local resident due to being a bus route and causing congestion at collection times. A request is to be presented for double yellows outside the library to deter inconsiderate parking.

ANPR cameras for installation at local schools to deter illegal and inconsiderate parking.
