Public Participation:

Mr J Cornwell presented a request for the representations made by the parish council for planning application 22/00244/FULEXT to be amended in relation to the referencing of street parking causing an obstruction at the entry points.

Mr G Harris expressed his concerns regarding the health of Cllr R Longton. Well wishes were also presented to the members not re-standing as parish councillors.

Mr G Harris requested the decision by the Community committee regarding the flagpole is not ratified by members present and reconsideration is given.

Mrs Y Mathos requested clarification as to whether the increase in the pitch fees would be reconsidered. Cllr T Ansell advised that in accordance with the parish councils standing orders, they would not be reconsidered for a further 6 months as the decision had been ratified by full council.
